TOURNAMENT RULES

- 1) The rules within this tournament will stand unchanged. If there is a question on any rule or regulation, the final decision will be left to the Tournament Committee.
- 2) All contestants must be sixteen (16) years of age or over unless participating with a parent or guardian.
- 3) Pre-meeting Saturday evening at 6:00 p.m. Sept. 9th.
- 4) All contestants will leave, fish the Tournament and return in the same boat.
- 5) TYPE OF TACKLE - Only casting, spinning or spin casting tackle may be used. Only one rod may be in use at one time. Other rods may be rigged and ready for use as substitutes. Only artificial lures may be used.
- 6) SAFE BOATING MUST BE OBSERVED AT ALL TIMES! - All boats and motors used must meet the required safety standards. Each contestant must wear a life-saving device during take-off.
- 7) Late Penalty - One pound per minute.
- 8) Ties for total weight will be broken by the biggest bass on each stringer. Ties for the biggest will be broken by the total stringer weight.
- 9) SCORING - There will not be a point system. All fish will be weighed in the same container. The largest bass weight will be without container. Any bass under twelve (12) inches will have one (1) pound deduction from total stringer weight.
- 10) It will be prohibited for any boat to have more than six (6) bass. Only Largemouth bass, Kentucky Spotted bass and Smallmouth bass will be weighed in.
- 11) No Alcoholic Beverages. Fishing hours to be set Saturday night.
- 12) AWARDS - The awarding of prizes and trophies will take place immediately after the weigh-in and tally is completed.
- 13) BOATS AND MOTORS - Electric trolling motors are permitted for moving the boat into and during fishing positions. TROLLING OF LURES IS PROHIBITED! No pontoon or barge-type craft will be permitted. A contestant may use his own boat and motor or he may rent one.
- 14) A percentage of the proceeds go to charity.
- 15) All live fish will be returned to the lake.
- 16) One (1) tenth will be deducted from each fish brought in dead.
- 17) Flight will be determined by the date entries received.
- 18) All contestants are subject to be given a lie detector/stress test at the decision of the Tournament Committee. Failure to pass the test means you will be disqualified and no money paid. This does not necessarily mean a team has cheated, but the team will be disqualified and again, no money paid.
- 19) All protests must be made within 15 minutes after the tournament ends. All protests must be made to the Tournament Committee.
- 20) The Tournament Committee reserves the right to disqualify any team, pay no money, and refuse entry refund.
- 21) We will be observing all fish being weighed in. Any fish appearing to be mauled, battered, or bruised will not be weighed in, and in cases where several fish appear to be mauled, mangled, bruised or battered, the team's catch may be disqualified.
- 22) No Fishing within Chaonia Landing Cove.
- 23) All Fishing must be from inside the boat. (No wading, etc.)
- 24) No Fishing above Greenville Highway 67 bridge.
