TOURNAMENT RULES

The rules of this tournament will stand unchanged. If there is a question on any rule or regulation, the final decision will be left to the Tournament Committee.

The Tournament Committee reserves the right to disqualify any team, pay no money, and refuse entry refund.

Fishermen must check in at the weigh-in station before leaving. Fishermen may leave the cove after 6:30am. Fishing will start at 7:00am.

All contestants must be 16 years of age or over unless participating with a parent, guardian, or parental approved adult.

TYPE OF TACKLE: Only casting, spinning or spin casting tackle may be used. Only one rod may be in use at one time. All other rods may be rigged and ready for use as a substitute. Only artificial lures may be used.

BOATS AND MOTORS: Electric trolling motors are permitted for moving the boat into and during fishing positions. A contestant may use his own boat and motor or he may rent one.

SCORING: There will be no point systems. All fish will be weighed in the same container and the gross amount of the bass will be posted.

Ties for total weight will be broken by the biggest bass on each stringer. Ties for biggest bass will be broken by the total stringer weight.

Only large-mouth bass and Kentucky spotted bass or small-mouth bass will be weighed. A limit of 5 bass per team will be accepted. (No length limit)

2/10 lbs. will be deducted per dead fish. All fish will be returned to the lake ALIVE if possible.

LATE PENALTY: One (1) pound per minute. Disqualification 15 minutes.

FISHING HOURS: 7:00 a.m. – 2:30 p.m.

No fishing will be permitted within fifty (50) yards of any boat dock or any contestant's boat that is first anchored.

No fishing inside idle buoys at Chaonia Landing boat dock.

SAFE BOATING MUST BE OBSERVED AT ALL TIMES! All boats and motors used must meet the required safety standards.

AWARDS: The awarding of prizes and trophies will take place immediately after the weigh-in and tally is completed. Food and beverage provided for participants after weigh-in.
